Blog Submission Guidelines:

- Submissions shall be made only in "English".
- All submissions must be in Times New Roman, font size 12, with line spacing 1.5
- The word limit for each post is 1200-1500 words (exclusive of endnotes).
- Please ensure the inclusion of endnotes instead of footnotes. All endnotes should be in Times New Roman, 12, with line spacing 1.5.
- Sub-headings must be in bold as well as underlined with font size 14.
- The citation style must be in conformation with The Bluebook, A Uniform System of Citation (20th Ed.)
- The work submitted shall be original and unpublished. More than 20% plagiarism in the manuscript shall be subject to rejection.
- The manuscript should be accompanied by a cover letter specifying the author's name, designation, institute, contact number, and email for future reference. (Authors are requested not to put their name anywhere in the main manuscript).
- Co-authorship to a maximum of two authors, of the same or different institutions, is permissible.
- All submissions must be mailed at editorial.tlg@gmail.com with the subject line "Blog Submission TLG" in .doc or .docx format.
- All copyrights to entries selected for publication are vested with the Editorial Board of The Law Gazette. However, all moral rights shall remain with the author(s).
- The manuscripts not abiding by the above guidelines are liable to be rejected.

Students, academicians, advocates, and other stakeholders associated with the field of law are invited to contribute to this blog.

Perquisites:
